

ORDINANCE NO. 517

AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF WORMLEYSBURG, CUMBERLAND COUNTY, PENNSYLVANIA, AMENDING CHAPTER 15 OF THE CODE OF ORDINANCES OF THE BOROUGH OF WORMLEYSBURG ENTITLED “MOTOR VEHICLES”

WHEREAS, Section 1202 of the Borough Code (8 Pa.C.S.A. § 1202) gives Borough Council the power to regulate streets and make regulations as may be necessary for the health, safety, and general welfare of the residents of the Borough; and

WHEREAS, the Borough Council of the Borough of Wormleysburg deems it to be in the best interest and for the general welfare of the citizens and residents of the Borough to amend Chapter 15 of the Code of Ordinances of the Borough of Wormleysburg entitled “Motor Vehicles”.

NOW THEREFORE, BE IT ENACTED AND ORDAINED by the Mayor and Borough Council of the Borough of Wormleysburg, Cumberland County, Pennsylvania, and it is enacted and ordained as follows:

SECTION I: Chapter 15 of the Code of the Borough of Wormleysburg entitled “Motor Vehicles,” Part 2 entitled “Stop Sign,” Section 214 entitled “Stop Intersections Established” is hereby amended to add the following:

Stop Street	Intersecting or Through Street	Direction of Travel
Ferry Street	Second Street	Eastbound
Second Street	Ferry Street	North and southbound

SECTION II: Chapter 15 of the Code of the Borough of Wormleysburg entitled “Motor Vehicles,” Part 4 entitled “General Parking Regulations,” Section 404 entitled “Parking Prohibited in Certain Locations Certain Days and Hours” is hereby amended to add the following:

Street	Side	Between	Days	Hours
Chestnut Street	North	North Front Street and 3rd Street	November 15th through March 15th each year	12:00 am – 11:59 pm

SECTION III: REPEALER. All provisions of previous Ordinances of the Borough of Wormleysburg which are contrary to this Ordinance are expressly repealed.

SECTION IV: SAVINGS CLAUSE. In all other respects, the Code of Ordinances of the Borough of Wormleysburg shall remain as heretofore enacted, ordained and amended.

SECTION V: SEVERABILITY. The provisions of this Ordinance are severable and if any of its sections, clauses, or sentences shall be held illegal, invalid, or unconstitutional, such provisions shall not affect or impair any of the remaining sections, clauses or sentences.

SECTION VI: EFFECTIVE DATE. This Ordinance shall take effect immediately.
