

WORMLEYSBURG BOROUGH COUNCIL MINUTES AUGUST 9, 2022

The monthly meeting of the Wormleysburg Borough Council was held on Tuesday, August 9, 2022 in Council Chambers. Dr. Deklinski called the meeting to order at 7:30 p.m.

The Pledge of Allegiance was led by Corporal Hair.

PUBLIC COMMENTS

No public comments.

APPROVAL OF THE MINUTES

ACTION: On motion made by Ms. Stuart and seconded by Mr. Stumpf the minutes

of July 12, 2022 meeting were unanimously approved as presented.

APPROVAL OF THE AGENDA

The agenda was accepted as presented with no changes.

BUILDING PLANS

There were no building plans.

PUBLIC HEARINGS

Dr. Deklinski recessed Council and opened the public hearing at 8:03 p.m. to receive comments on Ordinance 532 — Parking Ticket Fine Increase.

There were no comments.

Dr. Deklinski closed the public hearing at 8:04 p.m. He then reconvened the Council meeting.

ACTION: On motion made by Ms. Stuart and seconded by Mr. Kahler, Council

unanimously voted to adopt amended Ordinance 532 — Parking Ticket Fine Increase and rescind the existing Parking Ticket Fine Ordinance.

Dr. Deklinski recessed Council and opened the public hearing at 8:05 p.m. to receive comments on Ordinance 533 – Stormwater Ordinance Amendment.

There were no comments.

Dr. Deklinski closed the public hearing at 8:06 p.m. He then reconvened the Council meeting.

Borough Manager

Borough Engineer

The Borough Engineer report was provided electronically summarizing the status of the following projects and tasks to be performed:

i. 2022 Road Project – Received the final payment application from Kinsley and recommended payment.

ii. Walnut Street Drainage Project – Borough received full executed agreement from Norfolk Southern. Proof will be provided to PennDOT so a Highway Occupancy Permit can be obtained.

COUNCIL PRESIDENT'S REPORT

Dr. Deklinski advised that the Walnut Street Drainage Project has been approved by Norfolk Southern.

Dr. Deklinski reported that Orrstown Bank has volunteered to sponsor the Day of Kindness children's poster and that New Hope Ministries Food Pantry will be participating, as well.

Dr. Deklinski advised that the Hero Banner Program banners have been designed by Keystone Display and provided a design concept to Council. Dr. Deklinski noted that the American Legion Post 100 in Wormleysburg will assist with the publicity of the banners.

Planning Commission and Streets, Sanitary/Highway Committee

Mr. Plaza reported that PennDOT engineering and traffic studies will be performed for the South Front Street Speed Study. PennDOT requested 30 days after the study is completed for results to be determined.

Service/Property Committee

Mr. Kahler advised the mandatory Pre-Bid Meeting for the Borough Building Renovation Project had been held on July 18, 2022 at 9:00 a.m. Mr. Kahler noted that the bid opening is August 15, 2022.

Codes Enforcement, Zoning, Sidewalks and Shade Trees Committee

Ms. Stuart advised Codes Officer Eutzy continues to learn the iWorQ's codes and permit software.

Public Safety Committee

Mr. Stumpf reported that the WSBF had an abnormal month of increased activity.

Dr. Deklinski presented Corporal Hair with signed Resolution 2022.04.

Ms. Stuski asked that it can be reviewed if the speed limit on Walnut Street Between North Second Street and 12th Street be lowered from 45mph to 35mph.
