**CALL TO ORDER:**

The Monthly Business Meeting of the West Shore Regional Police Department Commission was held at 510 Herman Ave, Lemoyne, PA and called to order at 5:00 p.m. by Chairman Martini with Commissioner Preble leading the Pledge of Allegiance.

**APPROVAL OF MINUTES:**

**Motion:**

**TREASURER’S REPORT:**

Commissioner Preble reported balances of \$478,810.92 in the checking account, \$129,766.64 in the Capital Reserve Fund, \$7,279.24 in the donation checking account and \$17,603.94 in the K9 donation account as of January 31, 2019. Commissioner Preble also reported a balance of \$152,071.38 in the Centric Capital Reserve Fund as of January 31, 2019

**Motion:**

Commissioner Preble made a motion to approve the January 2019 Treasurer’s Report and to submit it for audit, seconded by Commissioner Panko. The motion passed unanimously.

Officer Conroy reported for December that he and K9 Max had six K9 assist calls outside of the jurisdiction and five K9 assist calls inside the jurisdiction. Five calls were for drug searches six were for searching/tracking. Officer Conroy and K9 Max also had 1 PR event.

Chief Hope asked the Commission if they would be willing to move funds from the Member's 1<sup>st</sup> Capital Reserve Fund to the Centric Capital Reserve Fund due to the fact that the Centric Capital Reserve fund now has an interest rate of 2% and is adding funds each month to the account.

**Motion:**

Commissioner Preble made a motion to move \$128,766.64 from the Member's 1<sup>st</sup> Capital Reserve Fund to the Centric Capital Reserve Fund, seconded by Commissioner Beasley. The motion passed unanimously.

Chairman Martini asked for another volunteer from the Commission to work with him and two representatives from the union on a committee negotiating the union contract that is up for renewal in the next year. Commissioner Beasley stated he would join the committee.
